### **MINUTES**

#### **OLD BUSINESS:**

- 1. *Community Park Turf* Director Dent would like the project to the done in November of 2017. E-layer may be needed. The bid has been completed but not submitted yet.
- 2. Camp Dawson Barn- Director Dent had no update.
- 3. *AED Training* Director Dent stated that all backgrounds checks will still be completed through Recreation. She would like to find out from all the organizations how many of their coaches are CPR/AED certified. AED's will be returned to the fields on March 1.
- 4. *Roller Hockey* The container was sold to the Board of Education. All equipment is being stored in the basement of Town Hall.
- 5. *Community Park Signage* Traffic flow arrows will be placed in the lower lot and the upper lot traffic flow will remain the same.

### **NEW BUSINESS**

Capital Budget – The Township Committee has requested that the Recreation
Commission contributes \$130,000 towards the balance needed to install new field
lighting at Masar and to upgrade the light timing system at the Community Park
Basketball Courts. Two items that were not approved were the upgrades to the Camp
Dawson snack stand and a new set of bleachers at Camp Dawson. Musco bid does
not include a tear down and disposal fee of \$15,000.

- <u>LACROSSE</u> Liaison Garb absent, emailed report. Registration without late fees is now closed.
- <u>MBSA</u> Liaison Kaufman stated that rec registration is closing soon. There are approximately 24 teams.

**SOCCER ASSOCIATION** – Liaison Axelrad confirmed that soccer will no longer run the concession stand at Community Park. There will be a tournament on April 1 with a rain date of April 8<sup>th</sup>.

**TOWNSHIP COMMITTEE** – Liaison Cook has no report.
