**INSTRUCTOR:** Mr. Max Weinstein learned chess when he was just 6 years old and started playing competitively at just 8. He has competed in chess tournaments as close as New Jersey, New York, Connecticut, and as far as Florida, Texas, and even Germany, and Israel. Most recently, Max coached the United States Junior Chess Team in the 21st Maccabiah Games in Israel this past summer. Max has been teaching chess for 6 years now in schools, libraries, and privately.

## **Waiver of Liability Relating to Coronavirus/COVID-19 for Participant (Minor)**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. It is reported to be extremely contagious, with no known treatments, cure or vaccine. COVID-19 is believed to spread mainly from person-to-person contact, however the exact methods of spread and contractions are still unknown.
