**WHO:** Grades K-2

**WHAT:** In this class the dancers will be focusing on the proper technique for both ballet and tap. They will learn the differences between using their toes and heels, and plies vs. relevés. The children will be learning basic tap technique such as shuffles, toe taps, digs, and corkscrews, along with tendues, rond de jambes. During class we will work on two combinations, one showing our ballet technique and one showing our tap technique. They will love to “boogie woogie”, and show off the steps they have learned.

## Waiver of Liability Relating to Coronavirus/COVID-19 for Participant

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. It is reported to be extremely contagious, with no known treatments, cure or vaccine. COVID-19 is believed to spread mainly from person-to-person contact, however the exact methods of spread and contractions are still unknown. People reportedly can be infected and show no symptoms and therefore spread the disease. Evidence has shown that COVID-19 can cause serious and potentially life threatening illness and even death.

**Montville Township Recreation has put in place preventative measures that abide by the New Jersey State Department of Health Guidelines to reduce the spread of COVID-19; however Montville Township Recreation cannot prevent you or your child from becoming exposed to, contracting, or spreading COVID-19 while participating in recreation sponsored programs or events. It is not possible to prevent against the presence of the disease. These services are of such value to me and my child that I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to participate in programs or events sponsored by the Montville Township Recreation Department.
